# 2. Declaration of Pecuniary and non-pecuniary interests None

#### 3. Public Forum

a) A member of the public has complained about large farm vehicles damaging the grass triangle outside her house. She has done some repair work but it still needs a great deal of work particularly on a large pothole. The very old signpost (it was suggested that this has been in position since 1926 maybe before) has been damaged, some letters have fallen off. In the past soft bollards were placed to protect the triangle but were damaged within three days. The contractor who owns the farm vehicles is said to be a Mr John Larter. Cllr Martin Wyard that there has been a lot of damage by vehicles throughout the village in particular a signpost was knocked down by contractors who were strimming, kerbs have been damaged and the 30 mph sign is still illegal and Highways have not been out to rectify this. The Chair thanked the visitor for reporting this matter.

Action: The Chair will get in touch with Highways to arrange a visit to the village to inspect the damage. Also he will get in touch with John Larter.

b) The village litter pick was very successful although fewer people turned out this year. On the Thursday prior to the litter pick Norse did a very good job of cleaning up the B1119, unfortunately two days later an amount of litter had appeared again.

c) The Chairman had a meeting with Monica Petzel and Adrian Kinsey regarding the village website. It was agreed that Monica would in future run the website. There will be quite a lot of work to change the current website and it was agreed to keep it similar but with a little dressing up. At the moment groups within the village clash with their events so it would be

useful to have a calendar of events on the new site. At the moment Juniper Barn have a diary but not everyone can get there. It is becoming increasingly urgent to replace the noticeboard which could also show a diary of events . It was suggested that it might be useful to create a few links in the village, including The White Horse and Facebook. Many people in the village run small businesses and a link to these would be interesting, also the village misses capturing peoples voices. It was said that it is important to build the Community.
